RESOLUTION MOFFAT LIBRARY OF WASHINGTONVILLE BOARD OF TRUSTEES ELECTION ON ADDITIONS TO AND RENOVATION OF THE MOFFAT LIBRARY BUILDING

WHEREAS, the Board of Trustees has determined that it is necessary to renovate, and construct additions to, the historic Moffat Library building that will remove non-historic and poorly designed additions leaving approximately 7,000 square feet of the original building and adding 5,000 square feet of additions to the building;

WHEREAS, a school district public library is authorized to require that the Board of Education call, gave notice of and conduct a special district meeting for the purpose of holding an election whether to authorize the issuance of obligations of the school district for construction of library facilities; and

WHEREAS, the proposed building construction project is an Unlisted action under SEQR and the Board of Trustees has determined that the action will not have a significant adverse impact on the environment.

THEREFORE, IT IS RESOLVED a) that the Board of Trustees requests the Board of Education of the Washingtonville Central School District ("School District") to call, give notice of and conduct a special district meeting and election on November 18, 2014, at the temporary Library building, located at 3348 Route 208, Building 2, Suite 2, Campbell Hall, New York, i) to authorize construction of additions to, and reconstruction of, the historic Moffat Library building located at 6 West Main Street, Washingtonville, New York, including original furnishings, equipment, machinery, apparatus, appurtenances, site and other improvements, and expenses in connection therewith at an estimated maximum cost of \$7,422,828.00,-andii) to authorize the School District to issue obligations in the maximum amount of \$6,922,828.00, and iii) to authorize and direct the appropriate taxing authority and to raise the amount necessary to annually pay principal, interest and redemption premiums, if any, on such obligations, together with all expenses relating to the financing of the aforesaid project, by annual levy of a tax upon the taxable real property within the School District's boundaries, but in no event an annual amount greater than \$ 642,000,00 er a maximum period of fifteen years, and that such annual amount shall be in addition to the amount presently raised annually by tax for the Library's annual appropriations, and b) the Board of Trustees hereby agrees, in the event the the special district meeting and election results in approval of the foregoing, to convey an interest in the Moffat Library building and affected grounds to the School District which shall be of such nature and duration as to facilitate the issuance of bonds or notes of the School District for the aforesaid purpose.
